4. First-aid measures

6. Accidental release measures

Personal precautions: No action shall be taken involving any personal risk or if you do not have suitable training or protection. Shut off all heating and ignition sources. Avoid breathing vapor or mist. Put on appropriate personal protective equipment (see Section 8).

Protective equipment and emergency procedures: Avoid dispersal of spilled material, runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution. Use inert absorbent or retention tubes in the event of a large spill.

Methods and materials for containment and cleaning up: Stop leak if without risk. Move containers from spill area. 7. Handling and storage

Precautions for safe handling: Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. Avoid contact with eyes, skin and clothing. Do not ingest. Avoid breathing vapor or mist.
